**GENERAL TERMS AND CONDITIONS AND PERSONAL GUARANTEE**

- 1. Credit Terms: 2%. 10 Days-Net 30:** To encourage early payment of invoices, a 2% discount is allowed off the price of the bill if paid within 10 days of the invoice date (discount period). The full amount of the bill is due between the 11<sup>th</sup> and 30<sup>th</sup> day (Credit Period). Invoices not paid within 30 days of the invoice date are considered past due. A service charge of 1 ½% per month (compounded monthly) will be added to all amounts billed if not paid by the end of the 30-day credit period.
- 2. WAIVER** the undersigned from any obligations stated herein.
- 3. No additional Credit will be extended** to past due accounts unless satisfactory arrangements are made with our credit department.
- 4. ATTORNEY FEES:** In the event either party files a lawsuit or hires a collection agency to enforce this agreement, the prevailing party shall be entitled to reasonable attorney fees, court costs, and collection costs. South Carolina law shall govern this agreement, and venue shall be in Greenville County South Carolina.
- 5. PERSONAL GUARANTEE:** If the credit customer is a corporation, LLC, Partnership, a trust or other legal entity, then those signing this application, whether signing as an officer or not, personally guarantee payment for all items purchased on credit by the company. This guarantee shall be binding on the undersigned, jointly and severally, and upon their successors and assigns, heirs and legal representatives.
